RECORD OF THE REGULAR MEETING MINUTES FOR THE BOARD OF DIRECTORS OF THE HIGH VALLEYS WATER DISTRICT January 17th, 2018

1. Call to Order, Pledge of Allegiance

President Wright called the meeting to order at 3:00 p.m. He then proceeded to lead everyone in the Pledge of Allegiance.

2. Roll Call

Secretary (and Office Administrator) Thornton called the roll. President Wright, Director Hughes, Director Van Sickle, Director Haaland and General Manager Houghton were all present. Also present were the following residents that signed in: Rose McNeil of Poppet Flats, Ann Clemens of Poppet Flats, Ann Moore of Poppet Flats, Steve Chittenden of Twin Pines, Ron Singerton of Twin Pines, Lori Cornell of Twin Pines and Kathleen Belwish of Poppet Flats. Vice President Pavey was absent due to illness.

3. Adoption and Adjustment of Agenda (additions and/or deletions) No adjustments were needed.

Motion to approve the Agenda for January 17th, 2018 as presented, made by Director Van Sickle and seconded by Director Haaland. Directors voted to approve the Agenda for January 17th, 2018 as presented, as follows;

4. Public Input

Ron Singerton: Stated that the Twin Pines pipe, which is located in front of the Water District's office, was not big enough to carry large amounts of rain. He talked of the severity of damage done by heavy rains years ago. He recommended putting in a larger pipe to accommodate heavy rains and prevent future damage. He also commented on the gravel that is currently in the District's office parking lot, which he believed was being used to fix the roads in Poppet Flats. He wanted to know why the gravel can't be stored there because it is an eye sore. He wanted to have all the material removed for the sake of the region's appearance, if possible. General Manager Houghton stated that the gravel was originally placed at the District because it was intended to be used to fix a couple of the steeper hills but he recently found out that it won't, so after they use what they need to in a few more areas, the gravel will be available for pick-up to anyone who wants it. President Wright responded stating that the Board would discuss this.

Steve Chittenden: Stated that he wanted to know how much of the tax money High Valleys Water District is spending on the Poppet Flats roads because he was concerned. He wanted to know if it was the Water District's obligation to always repair the roads or the citizens' obligation. He said that the District should focus on pipes and water, not road repairs, which Twin Pines does not benefit from. General Manager Houghton clarified that no money was being spent on roads that did not pertain to the water lines, whether it's a road above exposed pipes themselves or roads that are the only direct access that lead to the lines. He stated that he does not, and will not, spend District funds repairing someone's driveway just because or roads that have absolutely nothing to do with the water lines. He then showed

the before pictures of Big Horn in Poppet Flats where an exposed pipe was. The road that lead to that pipe was undrivable, so he and the technicians needed to repair it to gain access to that pipe. He stated that lower Twin Pines roads are fixed all the time in order to access the lines, it's just not as noticeable as Poppet Flats' repairs. They also had recently fixed the back roads in Twin Pines. Upper Twin Pines roads are all paved and maintained by the County, so the District does not need to do any repairs.

Ann Clemens: Stated that she was on the Water Board for twenty years, being the Vice-President for a number of those years, so she knew a lot of what went on in the District. She said that in the late 90's, \$100,000.00 was spent on Twin Pines' road alone. By California State Water Law, the pipes are required to be buried 18-20 inches below ground and many in Poppet Flats are not due to rains and traffic. She stated that she appreciated that the District was trying to fix this before the District was reported and authorities got involved. She does not like that the rumor mill's been terribly busy with the road repairs and hopes that Poppet Flats and Twin Pines can bury the hatchet and gets things taken care of.

Rose McNeil: Stated she wanted to be present in support of the things the District has been doing. She said that Poppet Flats and Twin Pines are a community that should be interested in working together to make things better, but notices there seems to be some resentment and is unsure why. She asked if money was given, would the roads be kept up for everyone to which President Wright responded that the District is not in the business of the upkeep of the roads and streets.

<u>Ann Moore</u>: Stated that most of the Poppet Flats residents that were present were there in regards to the repairs that were being done on Big Horn and Bear. They heard it was being done because of the pipes, which they were all in support of, but then heard the repairs weren't going to be done so she, and the others, had just wanted clarity.

President Wright thanked everyone for their comments. He then reviewed the handout from November's Board Meeting that stated the three specific street names in Poppet Flats, which also had two options of estimated costs to repair said roads. He asked General Manager Houghton if he had an estimated time on when it could be started, but he said since it was put on hold last meeting, he could not provide those details. He said he would make some calls tomorrow once the Board decides on what to do. President Wright stated that there was no need to re-discuss and re-vote on the road maintenance in Poppet Flats, which was decided at last month's meeting, since the repairs had already been approved by unanimous vote.

5. Adoption of the Regular Meeting Minutes for December 20th, **2017** No corrections were noted.

Motion to approve the regular meeting minutes for December 20th, 2017, as presented, made by Director Hughes and seconded by Director Van Sickle. Directors voted to approve the regular meeting minutes for December 20th, 2017, as presented, as follows;

6. Discuss and Vote on BBK Classes with Cabazon Water District

Secretary/Office Administrator Thornton informed the Board that she had been contacted by Elizabeth Lemus, Board Secretary for the Cabazon Water District, regarding upcoming classes that will be conducted by Steve Anderson of Best, Best, & Krieger for their newest Board Member. To help alleviate

costs of these classes, the High Valleys Water District, as well as other surrounding Districts, were invited to attend the AB 1234 and Sexual Harassment classes. At this time, Mrs. Lemus could not give a definite cost due to not knowing the total amount of participants, but estimated \$1,000 per class. However, the total cost will then be split evenly between all participating Districts. The date of these classes was also unknown at this time, but she stated they were hoping for March. Secretary/Office Administrator Thornton informed the Board that she had found free online webinars through the Rural Community Assistance Corporation (RCAC) for the AB 1234 certification, and that although highly recommended by legal counsel, the Sexual Harassment class was not a mandatory Board Member requirement. After discussion, the Board agreed that attending the physical classes would be more beneficial than a webinar. Since Vice President Pavey had recently completed her AB 1234 certification earlier in the month through a webinar, only four Board Members would be in attendance. However, it was again recommended that all five members attend the Sexual Harassment class, which is mandatory for the General Manager.

Motion to approve attending classes with Cabazon Water District, as presented, made by Director Hughes and seconded by Director Van Sickle. Directors voted to attending classes with Cabazon Water District, as presented, as follows;

She re-iterated that the District is currently a Landowner's District, which means that the number of votes someone has is based on their land value. Since they are one of the few Districts that still operate like this, the Board instructed her to look into changing the procedure to one vote per person, which was originally discussed at the Regular Board Meeting held on August 19th, 2015. Legal council will need to be included during the entire process, as well as the Registrar of Voters, to ensure everything is done accurately.
